

CPT CODES FOR INGRIP

What is a CPT Code?

CPT stands for Current Procedural Terminology. CPT codes are used to provide standardized language for healthcare professionals to describe medical, surgical and diagnostic services. This way, healthcare providers can easily report what services they have performed for the patient when submitting a claim to insurance.

Please note that CPT codes are different than IDC-10 codes. CPT codes are used to identify services rendered rather than patient diagnoses. IDC-10 codes are for patient diagnoses.

Disclaimer About CPT Acceptance:

While CPT codes are supposed to help standardize care, it is not a clear process. Many codes overlap with one another, and some insurance companies do not accept certain codes or might decide to not pay the healthcare professional, even if the code seems billable, further complicating which code is the proper code to use. Additionally, partial responsibility falls to the healthcare provider; if they do not properly code their medical bills, insurance companies will deny reimbursing for business. As such, we please ask that you do not rely on the below CPT code recommendations; InBody cannot guarantee that these codes will work for the InGrip; please utilize your best professional discretion.

Possible CPT Codes for InGrip:

CPT CODE	NAME	DESCRIPTION
97110	Therapeutic Exercise	Timed code. Therapeutic procedure, one or more areas, each 15 minutes; therapeutic exercises to develop strength, range of motion, and flexibility. This must involve direct contact time with the patient.
97530	Therapeutic Activity	Timed code. Dynamic activities used to promote improved function, typically utilizing multiple parameters such as strength, range of motion, motor control, balance, and endurance. Activities like sit-to-stands, transfers, bed mobility, or sports-specific training may fall into this category.
97750	Physical Performance Test or Measurement	Used to bill for functional capacity exams, isokinetic testing, and specific tests and measures related to balance, such as the Timed Up and Go. This is a timed code, and it is not medically reasonable or necessary to bill this service as part of a routine assessment or evaluation of rehabilitation services.
97161-97163	Physical Therapy Evaluation	Used during physical therapy evaluations. The actual code depends on the complexity of the evaluation, ranging from low to moderate to high complexity.
97164	Physical Therapy Re-Evaluation	Used to bill for a re-evaluation of an established physical therapy plan of care. It is applied when a current patient develops a new condition related to their existing condition.
97165-97167	Occupational Therapy Evaluation	Used for occupational therapy evaluations. The actual code depends on the complexity of the evaluation, ranging from low to moderate to high complexity.
97168	Occupational Therapy Re-Evaluation	Used for occupational therapy re-evaluations based on an established and ongoing plan of care.
97168-97172	Athletic Training Evaluation	Used for athletic training evaluations. The actual code depends on the complexity of the evaluation, ranging from low to moderate to high complexity.
